## PRIVACY POLICY OF VIDEO SURVEILLANCE RECORDS AT "EGLĖS SANATORIJA" AB

We adhere to the Regulation (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter – GDPR) and other legislation that protects Your information.

Data protection officer shall provide information about the processing of personal data in the Medical SPA.

#### Who processes Your data?

We inform you that when you visit the Medical SPA your personal image data will be processed by *Data controller* "Eglės sanatorija" AB (registration number of a legal person 152038626, address Eglės g. 1, Druskininkai, tel. (8 313) 60220, e-mail address office@sanatorija.lt) in adherence to the provisions of GDPR and in exercise of the obligations prescribed in the law.

#### Which, for what purpose, and on which legal grounds Your personal data is processed?

We inform you that when you are present in the Medical SPA and its territory, the Medical SPA will process the following data of Yours for the purposes of ensuring the safety of property, persons, and public order: the data recorded by video surveillance cameras, that is the images of persons and other physiological characteristics (e.g., movement and gait characteristics). Our collecting of information about You is lawful since we strive to ensure the legitimate interests of the Medical SPA, which is to ensure the safety of our own and Your property, safety of the persons, and public order.

The plan of the area surveyed with the placement of the cameras is approved by a separate order of the Director.

No information about You is collected from other sources.

You do not have to provide us with any information for this purpose.

#### For how long do we store Your data?

Video surveillance data is stored for 14 days;

#### To whom may we transfer Your data?

We may provide access to Your personal data to the Medical SPA owners, the employees that are responsible for the IT, server, archiving, and legal questions, and department managers, but obligating these service providers or employees to ensure data confidentiality and proper protection.

Your data is transferred to a security company "Argus" which has entered into a contract for personal data processing.

In defence of Your and our rights, visual information about You may be transferred to insurance companies, law enforcement authorities, external service providers, e.g., lawyers, IT service providers and other subjects offering similar services, state authorities, or private enterprises conducting audits or inspections.

# Do we transfer information about You beyond the boundaries of the European Economic Area? The information about You is not transferred beyond the boundaries of the European Economic Area. What rights do You have?

We inform that You, as a data subject, under the legal acts of data protection and if You were to submit a written *request*, may exercise these rights of a data subject:

- 1. The right to access the information about data processing;
- 2. The right to access the data;
- 3. The right to rectification or having incomplete data completed;
- 4. The right to erasure ("right to be forgotten") or to suspend the processing activities (except storing);
- 5. The right to limit the processing;
- 6. The right to data portability;
- 7. The right to object the data processing;
- 8. The right to lodge a complaint with the State Data Protection Inspectorate.
